Subject.: Approval for manufacturing of "Socket Weld Fittings up to size 2" & Butt Weld Fittings and Plate/Forged Flanges up to size 24" as per Indian Boiler Regulation, 1950.

Gentlemen,

With reference to your letter No. SE/DSB/P/01/2025-26, dated 10-02-2026, and subsequent to the visit of the competent person of this Directorate to your works on 01-04-2026, for the purpose of verification of your competency as a "Socket Weld Fittings, Butt Weld Fittings and Plate/Forged Flanges" Manufacturer, I have to inform you that, the same is found satisfactory. You are now provisionally permitted to manufacture "Socket Weld Fittings up to size 2" & Butt Weld Fittings and Plate/Forged Flanges up to size 24"" under the purview of Indian Boiler Regulations, 1950 & Maharashtra Boiler Rules, 1962 and its latest amendment under the supervision of this Directorate for the period up to 31.12.2026 subject to the following conditions:

1. Drawing for "Butt Weld/Socket Weld Fittings and Plate/Forged Flanges" to be manufactured should be submitted to this office, after paying necessary fee as prescribed, and approval should be obtained before commencement of manufacturing.
2. Maker's certificates of raw material, forgings/castings to be used for manufacturing of "Butt Weld/Socket Weld Fittings and Plate/Forged Flanges" should be submitted to this office, for scrutiny and acceptance before use.
3. "Butt Weld/Socket Weld Fittings and Plate/Forged Flanges" should be offered for inspection at various stages of manufacture as laid down in appendix "J" of Indian Boiler Regulation 1950.
4. Consumption record of raw material used in manufacturing "Butt Weld/Socket Weld Fittings and Plate/Forged Flanges" should be mentioned on back of certificates of the raw materials and produced to the Competent Person for verification & endorsement.
5. No Welding / repair on the "Butt Weld/Socket Weld Fittings and Plate/Forged Flanges" should be done unless prior permission from the Director of Steam Boilers, Maharashtra State is obtained.
6. As per rule 152(3) of Maharashtra Boiler Rules 1962, any change in Production/Quality Control related staff should be immediately informed to this office.
